

STATEMENT ON FEED ADDITIVES REGISTRATION
ACCORDING TO EC N° CR 1831/2003

At the moment the registration of phosphoric acid and phosphates as part in the production of feed is legally restructured:

PAPA members have prepared a feed additive registration dossier for orthophosphoric acid that meanwhile has been positively reviewed by EFSA.

The following phosphates (table 2) are considered as feed material by law in accordance with EC regulation N° 892/2010, EC regulation N° 575/2011 and EC regulation N° 68/2013. This means that these substances are not considered as feed additives from October 28th, 2010 onwards and are classified as feed material only since double classification is excluded by law.
